If you are required to test more than Medicare's usual and customary guidelines (three (3) times per day when you are receiving insulin injections OR one (1) time per day if you are noninsulin-dependent), we will need you to send us a copy of your blood glucose log.

Please include the following information:

- 1) Make sure your **first and last name** are printed on the front and back of the blood glucose log
- 2) Make sure your blood glucose log is dated by **month, date and year**
- 3) Make sure to include **at least 28 days** in a row of testing documentation
- 4) The blood glucose log must show testing dates of **one month before** the date of the order.
